1. What is this product about?

This product provides coverage against loss or damage to your mobile equipment (as specified in the schedule) which are not licensed for public road use. Mobile equipment means mechanically self-propelled vehicles and/or equipment such as forklift, excavator, mobile crane, tractor etc.

2. What are the coverages/benefits provided?

This policy covers loss or damage to your property due to:

- Accidental collision or overturning
- Fire, external explosion, self-ignition or lightning
- Burglary, housebreaking or theft

Optional benefits that you may wish to purchase by paying additional premium:

- Damage arising from, earthquake, volcano eruption, subterranean fire, flood, typhoon, hurricane, landslip, subsidence or sinking of soil/ earth, or other convulsion of nature
- Damage arising from strike, riot and civil commotion
- Accessories and spare parts

Notes :

- Duration of cover is for one year. You need to renew your insurance policy annually.
- The benefit(s) payable under eligible product is protected by PIDM up to limits. Please refer to PIDM's TIPS Brochure or contact Etiqa General Insurance Berhad or PIDM (visit www.pidm.gov.my).

3. How much premium do I have to pay?

This total premium that you have to pay may vary depending on the sum insured, type of property, purpose of usage, risk exposure, optional benefits required and our underwriting requirements.

4. What are the fees and charges that I have to pay?

5. What are some of the key terms and conditions that I should be aware of?

Importance of Disclosure

- Pursuant to Paragraph 5 of Schedule 9 of the Financial Services Act 2013, if you are applying for this insurance wholly for purposes unrelated to your trade, business or profession, you have a duty to take reasonable care not to make a misrepresentation in answering the questions in the application form (or when you apply for this insurance). You must answer the questions fully and accurately.
- Failure to take reasonable care in answering the questions may result in avoidance of your contract of insurance, refusal or reduction of your claim(s), change of terms or termination of your contract of insurance.
- The above duty of disclosure shall continue until the time your contract of insurance is entered into, varied or renewed with us.
- In addition to answering the questions in the application form (or when you apply for this insurance), you are required to disclose any other matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied.
- You also have a duty to tell us immediately if at any time after your contract of insurance has been entered into, varied or renewed with us any of the information given in the application form (or when you applied for this insurance) is inaccurate or has changed.

Sum Insured

You must ensure that your property is insured at the appropriate market value amount.

Policy Excess

The amount of loss you have to bear if your property is damaged in the accident.

Premium Warranty

The premium due must be paid and received by us within sixty (60) days from the inception date of the cover. Failing which, policy is automatically cancelled and we shall be entitled to the pro rata premium for the period we have been on risk.

Claim

Upon the happening of an incident which may give rise to a claim, you shall notify us as soon as possible.

6. What are the major exclusions under this policy?

This policy does not cover certain losses, such as:

- a) Loss or damaged caused by:
 - i. Any latent or mechanical defect, mechanical derangement, mechanical or electrical failures, breakages, depreciation, atmospheric conditions or any other gradually operating cause
 - ii. Mechanical or electrical breakdown or wear and tear
 - iii. Abnormal testing or intentional overloading of equipment or any experiment involving imposition of abnormal conditions
 - iv. Loss or damaged caused by overloading or strain
- b) Dishonest act of the insured's employees or with the connivance of the insured or the dishonest act of any person to whom the property is entrusted
- c) Loss of accessories and spare parts, tyres or wheels and the canopy
- d) Loss or damaged caused or arising out of earthquake, volcanic eruption, subterranean fire, flood, typhoon, hurricane, landslip, subsidence or sinking of soil / earth, or other convulsion of nature
- e) War, invasion, act of foreign enemy, hostilities or warlike operation (whether declare or not) or civil war
- f) Mutiny, strike, riot, civil commotion, military rising, insurrection, rebellion, revolution, conspiracy, military or usurped power, martial law or state of siege
- g) Act of terrorism
- h) Arising therefrom or any consequential from ionising radiations or contamination by radioactivity from nuclear radiations, nuclear fuel, nuclear waste or from combustion of nuclear fuel
- i) Nuclear weapon materials

7. Can I cancel my policy?

You may cancel your policy by giving written notice to us. Upon cancellation, you are entitled to a refund of the premium based on the unexpired period of insurance subject to the terms and conditions of the policy and minimum premium to be retained by us.
