1. What is Industrial All Risks Insurance (Tariff) ?

2. Know Your Coverages / Benefits

This policy covers:

Section I – Material Damage

The insurance covers the sudden, unforeseen and accidental physical loss, destroy or damage to the property covered due to any cause other than those excluded in the policy.

Section II – Business Interruption

The insurance covers the financial loss arising from business interruption or interference in consequence of loss, destruction or damage cover under Section I – Material Damage

Note:

1. Duration of cover is one year. You need to renew your insurance policy annually.

3. Know Your Obligations

For this Industrial All Risks Insurance (Tariff), as illustration you must pay an annual premium of:

Example: Industrial All Risks Insurance (Tariff), Premium Breakdown (e.g. Sum Insured: RM10,000,000.00)

+ Service Tax	8% or RM 1,152.00
+ Stamp Duty	RM 10.00
Total Premium Payable	RM 15,562.00
Commission (Up to 15% of Premium)	Up to RM 2,160.00

4. Other Key Terms

a) Non-Consumer Insurance Contract

- Pursuant to Paragraph 5 of Schedule 9 of the Financial Services Act 2013, if you are applying for this Insurance for a purpose related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to Our decision in accepting the risks and determining the rates and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in avoidance of your contract of insurance, refusal or reduction of your claim(s), change of terms or termination of your contract of insurance.
- The above duty of disclosure shall continue until the time your contract of insurance is entered into, varied or renewed with Us.
- You also have a duty to tell Us immediately if at any time after your contract of insurance has been entered into, varied or renewed with Us any of the information given in the Application Form (or when you applied for this insurance) is inaccurate or has changed.

b) It is important that you inform Us of any changes in your contact details to ensure that all correspondences reach you in a timely manner.

5. Can I cancel my policy?
