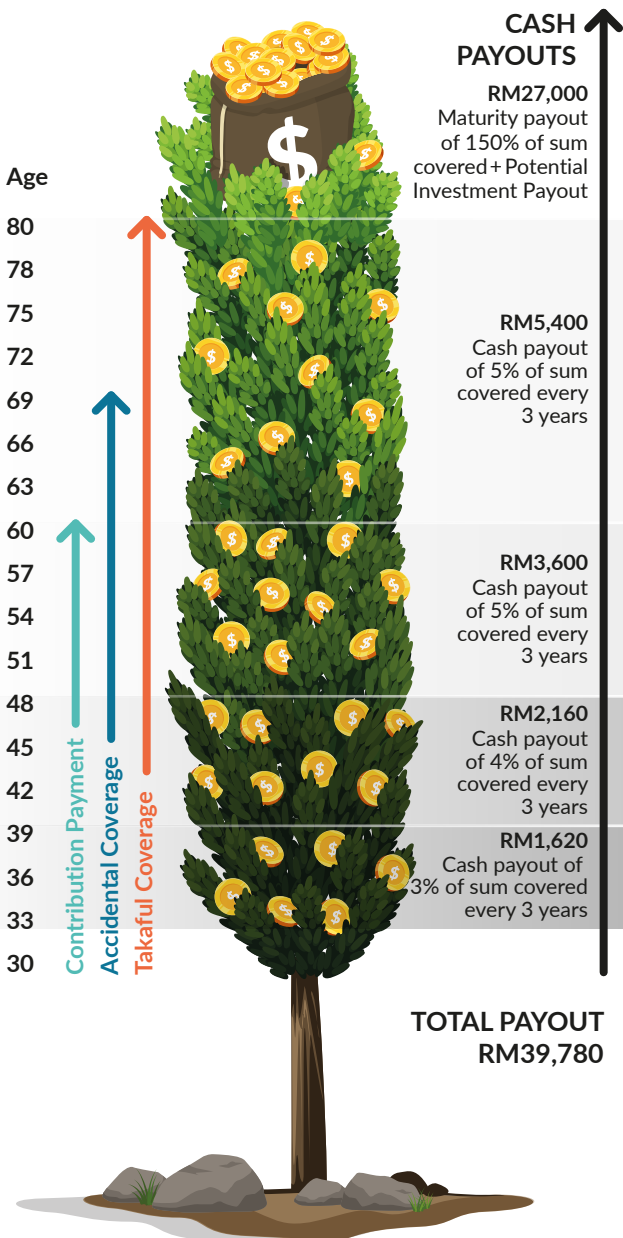

Aleeya, Age 30

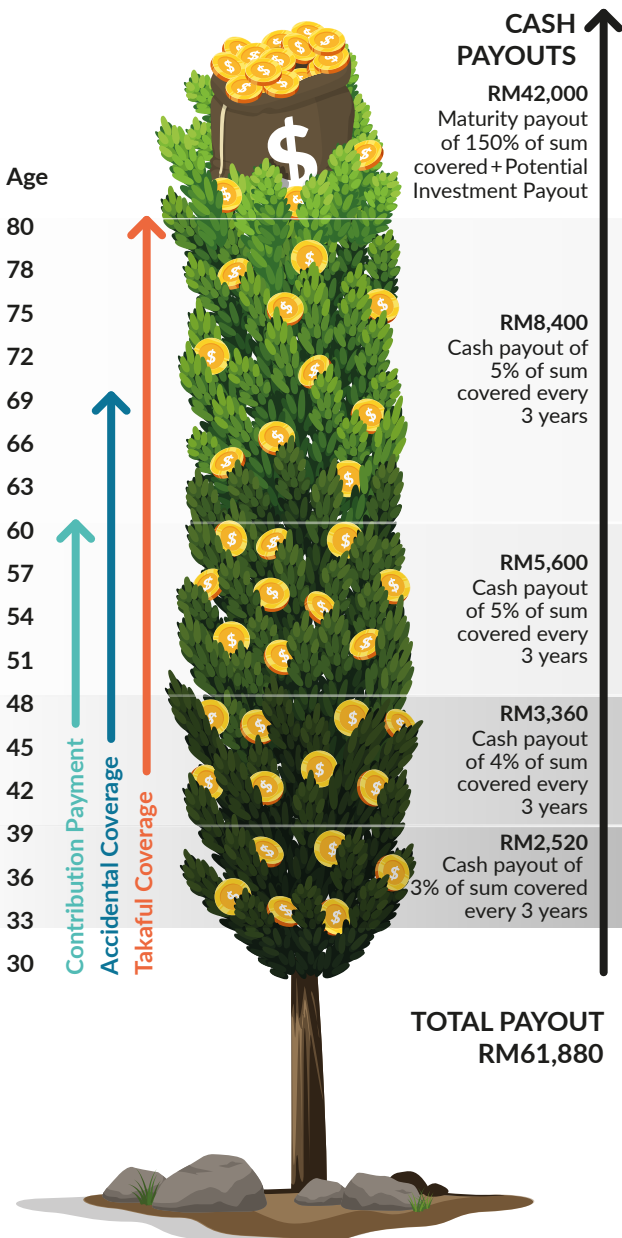

Aleeya, Age 30

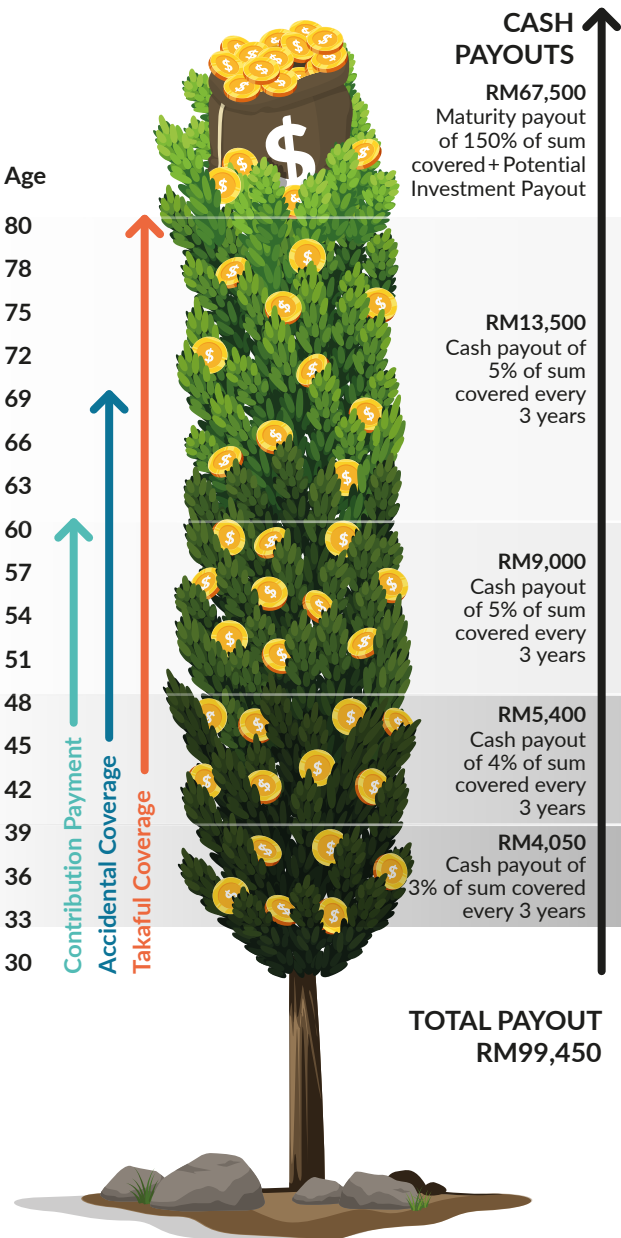
