**1. What is this product about?**

This certificate provides cover for loss or damage to your storage tanks and the contents within.

**2. What are the Shariah concept applicable?**

**Wakalah**

This product applies the Wakalah (agency) concept, whereby the Participants appoint Us to act on their behalf to invest and manage the General Takaful Fund (Fund). The Participants also agree to authorize Us to delegate Our rights, duties and obligations to any third party as We deem fit for the purpose of achieving the objective to invest and manage the Fund, provided that, in the event of any such delegation, We will remain liable and responsible for all such rights, duties and obligations towards the Participant. As an agent, We are entitled to receive a Wakalah Fee as a service charge whereby We shall have the full discretion to waive part of the Wakalah fee.

**Tabarru’**

This plan also applies the Tabarru’ (contribution) concept, whereby the Participants agree to donate or contribute their contributions to the Fund for the purpose of mutual aid and assistance to the Participants based on the pre-agreed events, in case of need. At the end of each financial year, any distributable surplus in the Fund, less repayment of historic deficits, makes allowance for contingency provisions, and is subject to the surplus policy approved by Our Shariah Committee is shared 50% among the Participants whose certificates have not terminated and who have not made any claims within the financial year, and 50% to Us for operating and managing the Fund, based on the contract of Ju’alah. Ju’alah is a wage contract that specifies the share of the distribution of surplus on this basis. If the surplus is less than RM10.00, it will be credited to charitable fund which will be utilized as ‘amal jariah’ on behalf of the participant. The charitable fund will be distributed to eligible recipients as approved by Our Shariah Committee for charitable purposes.

**3. What are the covers / benefits provided?**

This Certificate covers two aspects:

- Physical loss or damage to your storage tanks due to any unforeseen and sudden physical loss or damage from any cause other than those specifically excluded
- Physical loss of the contents of any storage tank following indemnifiable loss or damage to the tank

Duration of cover is for one year. You need to renew your Takaful Certificate annually.

The contribution are varies depending on the risk exposure and our underwriting requirements.

## 6. What are some of the key terms and conditions that I should be aware of?

- **Importance of Disclosure** - You must disclose all material facts that you know or ought to know; otherwise your certificate may be invalidated.
- **Non-Consumer Takaful Contract**
  - a) Pursuant to Paragraph 5 of Schedule 9 of the Islamic Financial Service Act 2013, if you are applying for this takaful for a purpose related to your trade, business or profession, you have a duty to disclose any matter that you know to be relevant to our decision in accepting the risks and determining the rate and terms to be applied and any matter a reasonable person in the circumstances could be expected to know to be relevant, otherwise it may result in avoidance of your contract of takaful, refusal or reduction of your claim(s), change of terms or termination of your contract of takaful.
  - b) The above duty of disclosure shall continue until the time your contract of takaful is entered into, varied or renewed with Us.
  - c) You also have a duty to tell us immediately if at any time after your contract of takaful has been entered into, varies or renewed with Us any of the information given on the Application Form (or when you applied for this takaful) is inaccurate or has changed.
  - d) In addition to answering the questions in the Application Form (or when you apply for this takaful), you are required to disclose any other matter that you know to be relevant to our decision in accepting the risks and determining the rates and terms to be applied.
- **Excess /Deductible**, being the amount you have to bear before we indemnify you.
- **Contribution Warranty** - The contribution due must be paid and received by the takaful operator within sixty (60) days from the inception date of this certificate/endorsement/renewal certificate.
- Failure to pay the contribution within this period, the contract is automatically cancelled and we are entitled to the pro rata contribution on the period you have been on risk.
- You must inform Us in writing on any material changes during the certificate period so that the necessary amendments are endorsed to your certificate.
- **Claims:** Upon the happening of an accident which resulting loss or physical damage to the Contract Work and gives rise to a claim, you shall notify us immediately.

## 7. What are the major exclusions under this Certificate?

This Certificate does not cover:

- the cost or replacement, repair or rectification of any tank which is defective in design, material or workmanship.
- breaking of glass, porcelain and similar materials.
- loss or damage as a direct consequence of the continual influence of operation (e.g. wear and tear, wearing away, wasting of the material, cavitation, erosion, corrosion, incrustation, rust) or of gradual deterioration due to atmosphere conditions.
- the cost of re-levelling any tank unless necessitated solely by an accident causing indemnifiable damage to the said tank.
- loss or damage directly or indirectly caused by or arising out of fire, lightning, flood, storm, explosion, aircraft or other aerial devices and/or articles dropped therefrom.
- penalties for delay or detention or in consequence with guarantees or performance or efficiency, liquidated damages or consequential loss or liability of whatsoever nature.
- Loss/damage from war, invasion, act of foreign enemy, hostilities, civil war, rebellion, revolution, insurrection, military or usurped power, riot, strike, lock-out, civil commotion.
- Loss/damage from ionising radiation or contamination by radioactivity, or from radioactive, toxic properties of nuclear components.
- Terrorism.
- Loss/damage to computer software.

## 8. Can I cancel my Certificate?

This Certificate may be terminated at the request of the Participant at any time in which case the Takaful Operator will retain the customary pro rata for the time this Certificate has been in force. This Certificate may equally be terminated at the option of Takaful Operator (provided it is necessary, reasonable and justifiable) by seven days' notice to that effect being given to the Participant, in which case the Takaful Operator will be liable to repay on demand a rateable proportion of the contribution for the unexpired term from the date of cancellation less any reasonable inspection charges the Takaful Operator may have incurred.

## 9. What do I need to do if there are changes to my contact details?

It is important that you inform Us of any changes in your contact details to ensure that all correspondences reach you in a timely manner.
